Senator Carlyle W. Begay



Senator Carlyle W. Begay (D-Ganado) was born on the Navajo Nation and he is Tó'tsohnii (Big Water), born for Kinyaa'áanii (Towering House) clans. Senator Begay is a lifetime resident of Arizona and grew up on the Navajo Nation near Black Mesa and was raised under the teachings of his ancestry, instilling in him the importance of remembering the story of his people and carrying it on to his descendants.

Senator Begay graduated from the University of Arizona with a Bachelor of Science degree in Molecular and Cellular Biology and was a student in the Minority Medical Education Program at the University of Arizona's College of Medicine. After

graduation, he continued his education and attended the W.P. Carey School of Business at Arizona State University earning a Master's degree in Health Sector Management. He also attended the Arizona International College's Natural Sciences and Mathematics program in Tucson, Arizona; Johns Hopkins Bloomberg School of Public Heath's Winter Institute, in Baltimore, Maryland; and the Harvard School of Public Health Studies program in Boston, Massachusetts.

Through these experiences Senator Begay accrued a tremendous acumen and passion for health and education policy and business. He has experience in the management of health care organizations, managed care, health care market structure, and health care delivery. Senator Begay has also devoted much of his career to improving education for all and ensuring, regardless of location or race, every person receives the first-rate education they deserve.

As state Senator representing legislative district 7, he has continued to give a voice to the Native American community and his constituents as a whole. He currently serves on the Senate committees of Education; Water & Energy; Transportation; and Financial Institutions. Additionally, he serves as co-chair of the Native American Caucus which considers issues that impact the community and works toward solutions that will make a meaningful difference.

Carolyn O'Neil (SWONAP Administrator)

Carolyn O'Neil, (Sault Tribe of Chippewa Indians) has been the Administrator for the Southwest Office of Native American Programs (SWONAP) since 2008; responsible for oversight of more than 150 tribes receiving approximately \$129,000,000 in IHBG and \$20,000,000 in ICDBG. Ms. O'Neil interacts with Tribal Leaders, Federal and State governments and the Representatives concerned with tribal issues. Unique to the SWONAP, Ms. O'Neil has created an Inter-agency collaboration of state and federal agencies which meets monthly to address and assist with the coordination of developing tribal

infrastructure in the southwest. Before assuming her current position Ms. O'Neil worked for 30 years in the housing division of the Sault Tribe of Chippewa Indians ending her 'first' career there as the Executive Director of Housing.

Marvin Ginn (Executive Director, Native Community Finance)



Marvin Ginn, an enrolled member of the Choctaw Nation of Oklahoma, is the Executive Director of Native Community Finance (NCF). NCF provides financial education, community oriented affordable loans, VITA/TCE tax site, IDA program, and mortgage assistance services. NCF is one of four certified Native Community Development Financial Institutions in New Mexico. Currently, he serves on three Boards which include the Housing Assistance Council (HAC), Native CDFI Network

(NCN) and the Credit Builder Alliance.

For over 20 years Marvin has gained experience working within Native Community housing and economic development. Prior to developing NCF, he served as the Director of Tenant Services for Laguna Housing Development and Management Enterprise (LHDME) as well as the Housing Director for the Pueblo of Jemez. He was also a Community Development Officer with the Bank of Albuquerque where he was instrumental in developing the HUD 184 loan program for the bank.

Marvin has always been an advocate for initiatives in Indian Country. He works with the Bureau of Indian Affairs Loan Guaranty program in order to obtain loans for Native entrepreneurs. Marvin also received recognition from the Bureau of Indian Affairs and the Federal Home Loan Bank for his work and input on the processing of Title Status Reports and recording of Tribal Land Leases. He also has served as the Chairman of the American Indian Chamber of Commerce of New Mexico for eight years.

Marvin is a certified financial and homebuyer trainer. In this capacity he has conducted many financial and homebuyer education classes for different tribes in the United States. Many of these classes were in conjunction with the National American Indian Housing Council.

He is a member of the Arizona Commission on Indian Affairs and serves on the Board of Directors for the following organizations: Native CDFI Network, Arizona Native Assets Coalition and the Construction In Indian Country Center. Mr. Castillo holds undergraduate and graduate degrees from Stanford University and a Master in Business Administration degree from the W.P. Carey School of Business at Arizona State University. Mr. Castillo is of Nahua Indian descent.
