- The AMERIND report was presented by Floyd Tortalita. Region 8 Fire Loss Ratio is at 14%. Nancy Harjo Serna, of AMERIND Risk, reported the next AMERIND event is The Institute at Sandia Resort, NM. Sessions are scheduled October 10-11, 2017, and include training and breakfast. SWTHA will have a booth at The Institute. AMERIND/ NAIHC Conference in San Diego May 30 June 1, 2018.
