#### NAHASDA Reauthorization

The Native American Housing Assistance and Self-Determination Act of 1996 (NAHASDA) is a powerful tool that provides greater housing opportunities and housing related community development in tribal communities. Since originally signed into law, NAHASDA has been reauthorized and amended several times. While the intention of each amendment is to improve the Act, there are still further refinements that may enhance the overall effective and efficient delivery of housing programs in tribal communities.

On January 14, 2015, <u>H.R. 360</u>, a bill to reauthorize NAHASDA was introduced by Representative Steve Pearce (R-NM) and 17 co-sponsors. Developed and championed by the National American Indian Housing Council (NAIHC), a non-profit housing and technical assistance organization, H.R. 360 would expedite required federal approvals, authorize tribes to blend housing construction money with sanitation facilities funding, launch a demonstration program for alternative privatization authority for Native housing, and other reforms. H.R. 360 was adopted by the House of Representatives on March 23, 2015 and referred to the Senate. A companion bill, <u>S. 710</u> was introduced by Senator John Barrasso (R-WY) March 11, 2015. That bill was favorably reported by the Senate Committee on Indian Affairs April 4, 2015 and was discharged by the Senate Banking, Housing and Urban Affairs Committee on August 4, 2015.

Near the end of September, Senate leadership ran a hotline on S. 710, a bill sponsored by Senator John Barrasso (R-WY) to reauthorize the Native

American Housing and Self-Determination Act (NAHASDA). Expected objections surfaced from Senator's Mike Lee 9R-UT) and Senator Ted Cruz (R-TX) on the native Hawaiian provision. The next step would be to identify time to bring S. 710 to the Senate Floor, allowing Senator Lee and Cruz to debate and memorialize their objections to the bill. NAIHC will provide information as it becomes available.

NAIHC message to Congress is to pass NAHASDA reauthorization legislation employing necessary strategies.

## Fiscal Year 2016 Appropriations Update

On September 30th, Congress passed a clean Continuing Resolution (CR) to continue funding federal programs at the same level in Fiscal 2015, averting another government shutdown. The CR that passed last week will expire on December 11<sup>th</sup>. The legislation does not contain controversial provisions or riders, thankfully.

Congressional Leaders spoke to President Obama last week to lay the groundwork for the budget summit, which leaders hope will set the top-line spending numbers for fiscal 2016 and 2017. The White House and Congressional leaders feel this would change from years of lurching from one fiscal crisis to the next. A two-year deal would set top spending levels and permit a more predictable process for the next couple years.

Included in all discussions on Capitol Hill are strategies to pass a highway funding bill this month and an increase to the debt limit sometime late November into early December.

NAIHC will monitor and report updates on these negotiations.

### **Census Bureau Plans Tribal Consultation**

The Department of Commerce - Bureau of the Census is announcing plans to conduct eight (8) Tribal consultations pursuant to Presidential Executive Order 13175, between October 2015 and April 2016.

# **Environmental Review October 27-29 | Phoenix, AZ**

Under the Native American Housing Assistance and Self-Determination Act of 1996 (NAHASDA) (25 U.S.C. 4101 et seq.), HUD provides grants, loan guarantees, and technical assistance to Indian tribes and tribally designated housing entities (TDHE) for the development and operation of low-income housing in Indian areas. Grants are made to eligible recipients under the Indian Housing Block Grant (IHBG) program. Grantees receiving funds under this program are responsible for meeting the requirements of NAHASDA and its implementing regulations, including compliance with HUD's environmental regulations 24 CFR Part 50 and Part 58.

<u>Professional Indian Housing Manager (PIHM) Certification:</u> Students will earn PIHM Certification upon successful completion of the following eight (8) courses offered under the NAIHC Leadership Institute:

- Financing Affordable Housing Development or NAHASDA LIHTC Compliance for Professional Certification
- 3. Financial Management
- 4. Project Management or Acquisition Basics or LIHTC Project Development
- 5. Supervisory Management
- 6. Admissions & Occupancy or Supportive Housing or Pathways Home
- 7. Property Maintenance Management

**HUD ONAP Offices of Grants Management and Grants Evaluation** requested OMB 2 CFR Part 200 Training. The request requires AAHA and NAIHC to collaborate as one team, under separate work plans in two phases:

<u>Phase 1</u>: Development of all training materials

<u>Phase 2</u>: Delivery of trainings (scheduling, contracting sites, marketing, registration, print and deliver of materials, and onsite logistics).

Delivery of first training will be **90 days after publication of the exceptions.** NAIHC will deliver nine (9) "comprehensive" <u>Instructor-Led</u> (IL) training events (2-3 days in length) to be held in cities of all ONAP regional offices with the exception that EWONAP and SWONAP may have two (2) events to cover geographic areas of their large regions. It is anticipated that AAHA will deliver the training events in Alaska and Hawaii.
