    - Motion to Approve by Ysleta Del Sur Pueblo and seconded by Laguna Housing Development & Management Enterprise
  - SWTHA Secretary/Treasurer: Rhoda Eustace, Zuni Housing Authority (Reappointed)
    - Motion to reappoint Rhoda by Ysleta Del Sur Pueblo. Rhoda accepted. Motion seconded by Pueblo of Jemez Housing Authority.
  - West TX Representative: Martha Beltran, Ysleta Del Sur Pueblo
    - The three members of Ysleta Del Sur Pueblo chose Martha as their representative.
  - NAIHC Representative: Jamie Navenma, Laguna Housing Development & Management Enterprise
    - Motion to reappoint Brook Kristovich by Zuni Housing Authority, seconded by Santo Domingo Tribal Housing Authority. Motion made by Pueblo of Acoma Housing Authority to take a vote. Santo Domingo Tribal Housing Authority withdrew their second to reappoint Brook.
    - An election was held to reappoint Brook or hold an election. It was voted that an election would be held for NAIHC Representative.
    - The Pueblo of Jemez Housing Authority made a motion to nominate Jamie. Hopi Tribal Housing Authority seconded the motion. Jamie accepted.
    - Santo Domingo Tribal Housing Authority made a motion to nominate Brook. Ysleta Del Sur Pueblo seconded the motion. Brook accepted.
    - A vote between Jamie and Brook was held. The vote was tied and was held again and still tied.
    - In case of a tie, the SWTHA Bylaws state, "The President shall cast the deciding vote in case of a tie" (ARTICLE V MEETINGS, Section 7. Voting).
    - In order to break the second tie vote, Chairman Floyd Tortalita voted to appoint Jamie as NAIHC Representative.
  - NAIHC Alternate Representative: Greta Armijo, Pueblo of Jemez Housing Authority (Reappointed)
    - Motion to nominate Veronica Ruiz was made by Santo Domingo Tribal Housing Authority, seconded by Zuni Housing Authority.
    - Veronica declined the nomination due to her duties as AMERIND Alternate Representative.
    - Motion to nominate Greta was made by Pueblo of Acoma Housing Authority, seconded by Hopi Tribal Housing Authority. Greta accepted.

- Motion to nominate Brook Kristovich was made by Ysleta Del Sur Pueblo, seconded by Santo Domingo Tribal Housing Authority. Brook accepted.
- A vote between Greta and Brook was held. Greta was voted to stay on as NAIHC Alternate Representative.
